The extrusions shall meet ASTM D 4726, classification (ASTM D 4216) 1-10154-33-0000, 1-20131-13-0000 or 1-40131-13 and the following properties.

In addition, each extrusion shall be labeled every 4 ft. or less on the underside with the Vision Extrusions Limited' extruder code and "MDCA".
